I very much support the proposed byelaws for the net and fixed engine fisheries.

Here in the North East, the existence of the mixed stock drift net fishery has been a national disgrace and it is quite correct that it is to be terminated earlier than originally planned.

The proposals for the fixed engine nets also make sense. The release of most salmon will protect the spring stock, whilst the shorter season for killing sea trout should enable this species to recover. The net free period will also allow for the development off a salt water sport fishery.
